Dear Sequoia Fund Shareholders:

For the second quarter of 2025, Sequoia Fund generated a total return of 14.35%¹ net of fees, versus 10.94% for the Standard and Poor's 500 Index. For the year to date through June 30, Sequoia Fund generated a total return of 19.65% net of fees, versus 6.20% for the Index.

We opportunistically added to our holdings in ICON and Universal Music Group and trimmed Credit Acceptance, Liberty Broadband, Jacobs, Meta and UnitedHealth to fund new investments in companies we'll disclose at a later date when our purchases are complete.

The expense ratio presented is from the Fund's prospectus dated May 1, 2025. For the year ended December 31, 2024, the Fund's annual operating expenses and investment advisory fee, net of such reimbursement, were 1.00% and 0.89%, respectively.
